This glove is a personal protective equipment belonging to the category II.

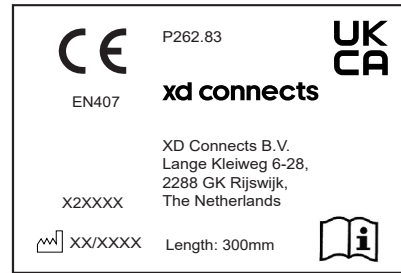
